Registration of Vendors under PM Surya Ghar: Muft Bijli Yojana in the State of Arunachal Pradesh

The State Nodal Officer (Rooftop Solar), Department of Power, Government of Arunachal Pradesh, on behalf of the governor of Arunachal Pradesh invites applications from the eligible vendors for registration under PM Surya Ghar Muft Bijli Yojana for Supply, Installation, Testing & Commissioning of Grid connected Rooftop Solar Photovoltaic Systems in Residential premises including five years comprehensive maintenance in the State of Arunachal Pradesh under PM Surya Ghar: Muft Bijli Yojana. The registration is open to all eligible vendors and registration shall be done on first come first serve basis. The invitation is open till 30 days from the date of publication of this invitation in the newspaper.

1. **Scope of Work:** Supply, Installation, Testing & Commissioning of Grid connected Rooftop Solar Photovoltaic Systems in Residential premises including five years comprehensive maintenance in the State of Arunachal Pradesh under PM Surya Ghar: Muft Bijli Yojana.

2. Time and place of submission of Application:

The vendor may submit their application along with requisite document to the office of the State Nodal Officer (Rooftop Solar), Department of Power, Govt. of Arunachal Pradesh, State Load Dispatch Building, Near 132/33 KV Sub-Station, Chimpu, ITANAGAR-791113 on all working days excepting Saturday and Holidays from 10.00 Hrs. to 17.30 Hrs.

3. Eligibility Criteria:

i. The firm will install rooftop solar plants fulfilling minimum technical standards and specifications issued by the MNRE. "Domestic Content Requirement" (DCR) of solar cell and module is mandatory as per guidelines of MNRE and for admissibility of Central Financial Assistance (CFA) to the applicants.

(Note: Rejection of CFA to consumer due to installations of SPV systems not conforming MNRE requirement shall be sole responsibility of the vendor)

- ii. The firm has sufficient (at least 3) technical manpower trained in the skills required to execute the work of installation of rooftop solar plants and the firm should have experience of installation of at least 10 kW SPV plant (Cumulative). Supportive documents to be submitted.
- iii. The vendor shall submit Format of Declaration (Annexure-1) attached hereto duly filled & signed with company seal on every page of the document.

4. Vendor Registration application Process:

i. The vendors willing to execute the projects in the State of Arunachal Pradesh through National Portal can get registered with the Department of Power by submitting an application along with a declaration as per **Annexure-1** (Also available at www.pmsuryaghar.gov.in, Vendor profile as in **Annexure-2** and depositing a Performance Bank Guarantee of Rs 2.50,000/- valid for at least 5 years as per **Annexure 3.**

- ii. Vendors can submit the application in their official letterhead appropriately signed and sealed at the office of the State Nodal Officer (Solar Rooftop) Department of Power in the address stated above. Their names will be included in the list of Registered vendors within a period of 1 month from the date of successful submission of the application. Empanelment list will be updated monthly.
- iii. The Department of Power will upload the details of the registered vendors on the National Portal and the vendors will receive a registration mail. The vendors can login to the National Portal with PAN number and Mobile number and enter the product rates and contact details. The details entered by the vendor will be visible to the consumer submitting application to the concerned Department of Power for rooftop solar.
- 5. **Process of Registration:** After obtaining the applications within every 15th day of month, Department of Power, Government of Arunachal Pradesh will verify the submitted documents for qualification and will ask the qualified agencies to submit the necessary Performance Bank Guarantee (PBG). After getting PBG from the agencies, list of empanelment of vendor will be uploaded in portal.
- 6. Department of Power, Government of Arunachal Pradesh reserves the right to accept or reject any or all applications at its discretion without assigning any reason whatsoever and does not bind itself to accept the application.
- 7. **Performance Bank Guarantee (PBG):** The qualified vendors have to submit a performance BG of Rs 2.5 lakhs valid for five years to The Executive Engineer (E), IT Division, Department of Power, Itanagar-791113. Format of PBG is enclosed (Annexure-3). Security money, pledge to the department of Power in any form, so retained shall not bear any interest whatsoever.
